## Terms and Conditions

These Terms of Service (“Terms”) apply to your access and use of all the annatel.cc services (collectively, the “Services”).

By accessing or using the services, you accept and agree to all these terms, and you represent and warrant that you are of legal age to form a binding contract. If you do not agree to these terms, do not access or use any of the services.

**1. SERVICES.** The Services may include conferencing services in any form (audio, video, over internet, over phone). In addition, the company offers assorted features and applications as part of its Services. Annatel.cc reserves the right, in its sole and absolute discretion and with or without notice to you, to change, limit, withdraw, modify, or end the Services, including without limitation any content, functionality, features, or services offered in connection with the Services or how you connect and interact with the Services.

**2. REGISTRATION.** To use the services, you’ll need to register. If any of the information provided during the registration process is not accurate, Annatel.cc reserves itself the right to suspend or delete your account without prior notice. You must be 18 years of age or older to register for the Service.

**3. FEES AND TAXES.** There may be fees associated with the use of certain Services. Although the Company does not anticipate any changes to its pricing policy, it reserves the right to institute new charges for access to or use of the Services at any time. Your continued use of the Services or non-termination of the Services after changes are posted constitutes your acceptance of the modified prices or Terms changes. **4. NO RESALE OR COMMERCIAL USE OF THE SERVICES.** Your right to use the Services is personal to You. You agree not to resell the Services, or other materials or any information obtained by you from annatel.cc without the express written consent of the Company.

**5. USER CONDUCT.** You are solely responsible for the content of Your transmissions through the Services. Your use of the Services is subject to all applicable local, state, national and international laws and regulations (including without limitation those governing account collection, export control, consumer protection, unfair competition, anti-discrimination or false advertising). In addition, You will not attempt to gain unauthorized access to other computer systems or attempt to override any security feature of the Services, and You will not interfere with another user's use and enjoyment of the Services or otherwise interfere with the proper functioning of the Services.

**6. PROPRIETARY RIGHTS.** You acknowledge and agree that the Services (including, without limitation, all content, information, data, items, materials, software, text, displays, images, video, and audio, and the design, selection, and arrangement thereof), are owned by annatel.cc, its licensors, or other providers of such material and are protected by Israeli and international intellectual property or proprietary rights laws. Annatel.cc and other names, logos, icons, and marks identifying products and services are trademarks of annatel.cc and may not be used without prior written consent. You may not copy, reproduce, distribute, lease, loan, rent, timeshare, deliver, or otherwise transfer, directly or indirectly, the account access granted to You (in whole or in part) or create derivative works of this Service without annatel.cc’s prior written consent. In addition, You may not reverse engineer, decompile, alter, modify, disassemble, or otherwise attempt to derive source code from the Services. All rights not expressly granted in these Terms are reserved to annatel.cc.

**7. PRIVACY.** Annatel.cc can use any personal information You provide as long as it is used to provide the Services

**8. MODIFICATIONS.** Annatel.cc may amend these Terms at any time by posting revised Terms on the Service. All changes are effective immediately when posted, and will apply to all access and use of Services thereafter. You are responsible for regularly reviewing the Terms. Your continued use of the Services after amended Terms have been posted or information regarding such amendment has been sent to You constitutes your acceptance of those Terms.

**9. PASSWORD AND SECURITY.** Annatel.cc will initially generate Your dial-in numbers and access codes for access to this account and service platforms. You must carefully safeguard all of your account numbers. You are solely and exclusively responsible if You do not maintain the confidentiality of account information. In addition, You are solely and exclusively responsible for any and all activities that occur under Your account. You must immediately notify Annatel.cc of any unauthorized use of Your account or any other breach of security known to You, including if You believe that Your account information has been stolen or otherwise compromised.

**10. TERMINATION.** Annatel.cc may immediately terminate Your Account and right to use the Services if: (i) You breach these Terms; (ii) we are unable to verify or authenticate any information You provide to us; (iii) you provide false, misleading, or otherwise inaccurate information to us; or (iv) we decide, in our sole and absolute discretion, to discontinue offering the Services. Should You object to any of the Terms, or any subsequent modifications thereto, or should you become dissatisfied with the Services in any way, Your sole recourse is to immediately: (1) discontinue use of the Services; (2) terminate your membership; and (3) notify us of termination.

**11. DISCLAIMER OF WARRANTIES.** You expressly agree that use of the service is at your sole risk. The services are provided on an "as is" basis. Annatel.cc expressly disclaims all warranties of any kind, whether express or implied, including, but not limited to, the implied warranties of merchantability, fitness for a particular purpose, and non-infringement. **14. GENERAL TERMS.** These Terms are governed in all respects by the laws of the Israel. Both Parties submit to personal jurisdiction in Israel and further agree that any cause of action relating to these Terms shall be brought in a court in Israel. If any provision of this Agreement is held to be invalid or unenforceable remaining provisions shall remain valid and enforceable. Annatel.cc's failure to act with respect to a breach of these Terms by You does not waive its right to act with respect to subsequent or similar breaches. You may not assign or transfer these Terms or any rights hereunder, and any attempt to the contrary is void. These Terms shall inure to the benefit of and be binding upon each Party's successors and assigns. Annatel.cc shall not be liable for any delay or failure to perform resulting directly or indirectly from any causes beyond annatel.cc reasonable control. These Terms constitute the complete and exclusive understanding and agreement of the parties relating to the subject matter herein and supersedes all prior understandings, proposals, agreements, negotiations, and discussions between the parties, whether written or oral.
